6. **Form of Request**

To facilitate the processing of your request, kindly:

- 6.1 Use the prescribed form, available on the website of the SOUTH AFRICAN HUMAN RIGHTS COMMISSION at www.sahrc.org.za.

- 6.2 Address your request to the Head of the applicable Group Company (CEO).
- 6.3 Provide sufficient details to enable the applicable Group Company to identify:
- a) The record(s) as requested;
 - b) The requester (if an agent is lodging the request, proof of capacity);
 - c) The form of access required;
 - d) (i) The postal address or fax number of the requester in the Republic;
(ii) If the requester wishes to be informed of the decision in any manner (in addition to written) the manner and particulars thereof;
 - e) The right which the requester is seeking to exercise or protect with an explanation of the reason the record is required to exercise or protect the right.

7. **Prescribed Fees**

The following applies to requests (other than personal requests):

- 7.1 A requestor is required to pay the prescribed fees (R50.00) before a request will be processed;
- 7.2 If the preparation of the record requested requires more than the prescribed hours (six), a deposit shall be paid (of not more than one third of the access fee which would be payable if the request were granted);
- 7.3 A requestor may lodge an application with a court against the tender/payment of the request fee and/or deposit;
- 7.4 Records may be withheld until the fees have been paid.
- 7.5 The fee structure is available on the website of the SOUTH AFRICAN HUMAN RIGHTS COMMISSION at www.sahrc.org.za.

8. **Protection of Personal Information Act**

- 8.1 This manual is to be read together with the BMA Group of Companies' policy in terms of the Protection of Personal Information Act 4 of 2003 (the **POPI manual**). The POPI manual is published together with this PAIA manual and is furthermore available upon request from the information officer.

- 8.2 The POPI manual contains, amongst other things, information pertinent to:
- (a) The purpose for which we process personal information;
 - (b) The categories of data subjects in respect of which we process personal information, and the categories of information relating thereto;
 - (c) The categories of recipients to whom we supply personal information;
 - (d) Any planned transborder flows of personal information; and
 - (e) A description of the information security measures which we implement to ensure the confidentiality, integrity and availability of the personal information which we process.
